- 2. A candidate having joined status on completion of round 2 and willing to participate for upgradation in round 3 will be eligible only on fresh application and on depositing security amount again. His/her earlier deposited security amount will be forfeited.
- 3. All registered candidates (EXCEPT FOR THOSE WHOSE DOCUMENTS HAVE BEEN VERIFIED IN ROUND 1 or 2 AND ALLOWED PARTICIPATION IN ROUND 2) must present themselves personally along with all original relevant documents and 2 sets of self- attested photocopies of the same (as mentioned in the instruction booklet) on the scheduled date and time for verification of the documents. Candidate who does not come for verification within the stipulated period or whose documents are not verified or found incomplete or on verification he/she is found ineligible, shall not be allowed to participate in the respective round of counselling process.
- 4. **All PwD candidates** must present themselves physically for document verification before the admission board on 23.08.2024 as per the notification and the list to be made available at the website.
- 5. All concerned / fresh candidates are required to deposit non-refundable application fee of Rs. 4000/- (Rs. 3000/- for SC, ST, ST-STA category candidate of Rajasthan state domicile) + applicable transaction charges.
- 6. All such candidates having joined status up to Round 2 who retain their seat in Round 3, will have to complete all other formalities of their allotted college (Refer to respective College Website) at the time of joining for Round 3.
- 7. The candidates are advised to visit the websites regularly for registration and other relevant information.

Important: For candidates willing to participate/upgrade in Round 3, it is mandatory to fill fresh choices in Round 3 (irrespective of whether the candidate was allotted/joined a seat in Round 1 / Round 2 or not).

The choices filled by candidate in Round 2 shall be scraped and will not be considered for Round 3. If a candidate does not fill fresh choices for Round 3, then he/she will not be considered for allotment/upgradation in Round 3.
